

Outsourcing of Cleaning & Gardening Services

Terms of Reference

Background

SOS Children's Villages in Kenya is a member of the SOS Children's Villages International (CVI) Federation. SOS Children's Villages in Kenya is a child-focused Non-Governmental Organization established in 1973 to provide care and support to children who have lost or are at risk of losing the care of their biological family.

The organization's vision is "No child should grow up alone" and its programmes are driven by the mission of "building families for children in need, helping them shape their own futures and sharing in the development of their communities". In this regard, the organization works to reduce poverty; increase access to quality education and decent work; reduce inequalities and build strong institutions as laid out in Sustainable Development Goals (SDGs) 1, 4,8,10 and 16.

This is done through programs that are geared towards addressing the political, economic, health and social root causes that lead to high levels of child vulnerability and put families at risk of breaking down. The programs focus on Alternative Care, Family Strengthening, Youth Empowerment, Education, Health Care and Advocacy. The mission of SOS Children's Villages Kenya is to build families for children in need, help them shape their own futures and share in the development of their communities.

1. Scope of Work

- To provide office-cleaning and allied services of high industry standards using environmental friendly products and supplies.
- Preparing tea for staff and visitors in all SOS Children's Villages Kenya offices provided in the schedule.
- Gardening services in all SOS Children's Villages Kenya offices provided in the schedule.
- To provide thorough cleaning services during the weekend both internally and externally in all the offices provided in the schedule.

2. Deliverables





- Thorough cleaning and mopping all floors within the SOS Children's Villages premises
- Dusting all the workstations, equipment, cabinets, drawers and chairs.
- Cleaning interior and exterior windows and glass surfaces
- Cleaning of all washrooms and their fixtures;
- Cleaning and polishing the wooden floors on request
- Scrubbing parking areas with shampoo
- Garbage disposal into the rubbish bins
- Vacuum cleaning of all carpeted areas
- Scrubbing of all ceramic floors
- Preparing tea for staff and visitors
- Trimming and maintenance of hedges and fences
- Mowing of grass in the garden areas
- Maintaining of flowerbeds.
- Ensure the generators are maintained as scheduled and always fueled
- Observe flexible timing.

Responsibility of the service provider

- To provide supervision of service provider's personnel
- To provide all detergents to be used in executing the tasks
- To provider all tools for the gardening

4. Profile of the Service Provider

- Financially sound and stable, evidenced by authentic financial statements for the past two years of operation
- The personnel must have training and experience in similar environments; and must not have criminal records or pending court cases against them.

(iii) Financial Evaluation and Price/Cost Analysis

All bidders who pass all technical criteria will move on to the financial evaluation where the lowest price offer(s) will be accepted as the winning offeror(s) assuming the price is deemed **fair and reasonable** and subject to the additional due diligence. Qualified and interested bidder are required to provide a comprehensive quotation for the services.

Additional Due Diligence

Upon completion of both the technical and financial evaluations SOS Children's Villages Kenya may choose to engage in additional due diligence processes with a particular offeror or offeror(s). The purpose of these processes is to ensure that SOS Children's Villages Kenya engages with reputable, ethical, responsible suppliers with solid financials and the ability to fulfill the contract. Additional due diligence may take the form of the following processes (though it is not limited to):

- Reference Checks
- Supplier's facility visits
- Analysis of audited financial statements
- Determination of relations and affiliations between bidders.
- Call for virtual/physical presentations
- Other appropriate documented method giving SOS Children's Villages Kenya increased confidence in the supplier's ability
